As per the Hon'ble Court order dated 16.10.2000 that the five objects namely (i) Krishna with flute (ii) Deepa Lakshmi Standing (2 Nos) of the writ petition No. 672/98 and (i) Standing Parvati and (ii) Casted Lady lamp of writ petition No. 3747/97 were again examined on merits on 3.10.2001 in the office of the Director General Archeological Survey of India, Janpath New Delhi.
